5. Sealed bids must be submitted to the office of Gandaki Rural Municipality Executive by hand [or through insert the name of e-GP system i.e www.bopatra.gov.np/egp] on or before 12 hours on 29 March 2019. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13 hours on 29 March at the office of Gandaki Rural Municipality Bhumlichok Gorkha. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of [insert amount 16000, which shall be valid for 30 days beyond the validity period of the bid]. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **3060303007105** at Rastriya Banijya Bank Gorkha and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
