- 6. Electronic bids must be submitted to the office of *Gandaki Rural Municipality* by hand/courier or through PPMO website <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on 2081/08/09. Bids received after this deadline will be rejected.
- 7. The bidders are informed to attach supporting documents to verify the Qualification Criteria.
- **8.** The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 2081/08/09** at the office of **Gandaki Rural Municipality.** Bids must be valid for a period of **30 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **2,50,000/**, which shall be valid for 30 days beyond the validity period of the bid.
- 9. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
