Bidding is open for all eligible Nepalese Bidders.
- 2. Office Of Gandaki Rural Municipality Executive invites sealed bids or electronic bids from eligible bidders for the construction of Ward -04 Office Building under National Competitive Bidding procedures.

- 4. A complete set of Bidding Documents may be purchased from the *Office Of Gandaki Rural Municipality Executive* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of *3000.00 Neplese Rupee* till *17 February 2019 During Office Time*.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Website www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of 3000 Nrs of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - Sealed or electronic bids must be submitted to the office of Municipality Executive, Gandaki Rural Municipality-06, Bhumlichok Gorkha by hand/courier or through PPMO website www.bolpatra. gov.np./egp on or before <u>12 hours on 18 February 2019</u>. Bids received after this deadline will be rejected.
- 6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 1 hours on 18 February at the Office of Gandaki Rural Municipality, Gorkha. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 190000.00, which shall be valid for minimum 30 days beyond the bid validity period. If bidder wishes to submit bid security in the form of cash, the cash should be deposited at office bank account, Rastriya Banijya Bank, Gorkha, Account No. 3060303007105 and submit the receipt of the deposited amount of cash with the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
